



The list below shows planned construction activities for the South Bay *Rapid* project. Travelers are encouraged to allow extra time to reach their destination or consider using alternate routes. Please note, construction schedules are subject to change.

Construction activities for the week of December 4

Interstate 805 to Heritage Road (Segment 1A) – City of Chula Vista

- Lane closures along westbound East Palomar between Davies Drive and Medical Center Drive. These closures are in place 24/7 for retaining wall and utility relocation work. Pedestrian detours will be in place.
- Lane and sidewalk closures along westbound East Palomar Street between Heritage Road and Paseo Ladera. These closures are in place 24/7 during sidewalk demolition and construction.
 - Travelers are encouraged to consider an alternate route between 8 a.m. – 9 a.m. to avoid elementary school traffic.
- Temporary bus stop closure along East Palomar Street at Brashear Place. For MTS schedules, detours, and routes during this closure, please visit www.SDMTS.com

Heritage Road to View Park Way (Segment 1B) – City of Chula Vista

- Periodic noise, dust, lane closures, and reduced on-street parking in both directions along East Palomar Street between Olympic Parkway and View Park Way for continued road work improvements.
- Daytime closure of one eastbound lane along East Palomar Street between Santa Rosa Drive and View Park Way for parkway landscape restoration work.

Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista

- Periodic noise and lane closures on East Palomar Street at Magdalena Avenue on Saturday, December 9 between 9 a.m. and 4 p.m. for the hauling of backfill material. Flaggers will be on-site to assist motorists.
- Periodic noise and dust along Impressionist Drive for construction of the guideway bridge.
- Periodic noise, dust and daytime lane closures along East Palomar Street between Olympic Parkway and Magdalena Avenue for installation of utilities.
- Periodic daytime closures of the left-turn pockets on northbound East Palomar Street to Olympic Parkway. Flaggers will be on-site to assist motorists. Motorists can expect short delays.

Town Center Drive to Birch Road (Segment 2) - City of Chula Vista

- Work near the Otay Ranch Town Center has been placed on hold during the busy shopping season for public convenience.

Millenia – City of Chula Vista

- Periodic noise and dust near the Millenia development for construction of the dedicated transit guideway and Millenia *Rapid* Station.

Nicola Tesla Court (Segment 3) – City of San Diego

- Periodic noise and dust along the eastbound 905 on-ramp from Siempre Viva Road from construction activities on the ramp.
- Periodic noise, dust, and reduced on-street parking at Nicola Tesla Court near the Otay Mesa Port of Entry to accommodate grading and construction of storm drain facilities and a retaining wall
 - No on-street parking on south side of Nicola Tesla Court.
