Please note, construction schedules are subject to change and community members may see trucks and staged equipment at various locations around the project.

Construction activities for the week of December 18

Interstate 805 to Heritage Road (Segment 1A) – City of Chula Vista

- Lane closures along westbound East Palomar between Davies Drive and Medical Center Drive. These closures are in place 24/7 for retaining wall and utility relocation work. Pedestrian detours will be in place. The bus stop east of Medical Center Drive has been relocated to the west side of Medical Center Drive.
- Lane and sidewalk closures along westbound East Palomar Street between Heritage Road and Paseo Ladera. These closures are in place 24/7 during sidewalk demolition and construction. Travelers are encouraged to consider an alternate route between 8 a.m. and 9 a.m. to avoid elementary school traffic.
- Temporary bus stop closure along East Palomar Street at Brashear Place. For MTS schedules, detours, and routes during this closure, please visit www.SDMTS.com.

Olympic Parkway to State Route 125 (SR 125) (Segment 2) – City of Chula Vista

- Periodic lane and sidewalk closures along northbound Magdalena Avenue between Caminito Treviana and the median on East Palomar Street, beginning Monday, December 18 through Friday, December 22, between 7:30 a.m. - 3:30 p.m. Two way traffic will be facilitated by flaggers. This work will allow crews to install storm drains. No-parking restrictions may be in place along the work area.
- Periodic noise, dust and daytime lane closures along East Palomar Street between Santa Cora Avenue and Magdalena Avenue for installation of utilities.
- Periodic daytime closures of the left-turn pocket on northbound East Palomar Street to Olympic Parkway between 8:30 a.m. and 3:30 p.m. A portable message board will be in place to alert motorists. Motorists can expect short delays.
- Periodic noise and dust along Impressionist Drive for construction of the guideway bridge.

Town Center Drive to Birch Road (Segment 2) - City of Chula Vista

- Work near the Otay Ranch Town Center has been placed on hold during the busy shopping season for public convenience.

Millenia – City of Chula Vista

- Periodic noise and dust near the Millenia development for construction of the dedicated transit guideway and Millenia *Rapid* Station.

Nicola Tesla Court (Segment 3) – City of San Diego

- Periodic noise and dust along the eastbound State Route 905 (SR 905) on-ramp and off-ramp from Siempre Viva Road from construction activities on the ramps.
- Periodic noise, dust, and reduced on-street parking at Nicola Tesla Court near the Otay Mesa Port of Entry to accommodate grading and construction of underground facilities and a retaining wall.
 - No on-street parking on south side of Nicola Tesla Court.
